## Terms & Conditions - The Zombie Card

The Zombie Card is a debit card. Daily limits apply for point of sale and ATM usage. Your ATM limit is \$200 per day. Your Point of Sale limit is \$500 per day. If you need us to raise these limits for specific time frames, give us a call and we'll set you up.

I understand that I am the only individual authorized to use the card and that use of the card signifies agreement to the terms and conditions set forth in the Electronic Funds Disclosure Agreement. The MasterMoney debit card is the property of Element Federal Credit Union and can be cancelled at any time without prior notice.

When I open The Zombie Card, I'll be opening The Zombie Card transaction account as well. This is the account where I will deposit funds for my debit card. When I make purchases or withdrawals with The Zombie Card, these amounts will be deducted from this account.

- Login to ItsMe247 online banking once per calendar month

\*\* No minimum balance to maintain account. \$50.00 minimum to open account. Requirements must be met each monthly statement cycle to receive 5.00% APY\* on the portion of the balance up to \$2,000.00. Amounts over \$2,000.00 will earn .10% APY\*. If qualifications are not met, the APY\* is .01% on the entire balance. The monthly statement cycle is the 1st through the last day of each calendar month. There are no rollover transactions. Qualifying signature debit card transactions include each time you use your Element debit card to make a purchase from a vendor or merchant. These transactions must post and clear your account during the payment cycle. ATM and ACH transactions do not qualify. Limit of one Infinite Checking per individual. You must be enrolled in eStatements to qualify for this account. This is a variable rate account and the interest rate can change. Fees could affect the earnings on this account.
